(b) In consideration of these facts, the parties agree that:





Dear Mr. Branch:

I, James L. Gallagher, am the Secretary of Enterprise Services LLC a Delaware limited liability company, and am delivering this opinion pursuant to Federal Acquisition Regulation ("FAR") 42.1205(a)(2) in connection with the change of the legal entity name by Enterprise Services LLC from Enterprise Services LLC to Perspecta Enterprise Solutions LLC. Enterprise Services LLC holds the contracts set forth on Exhibit A attached hereto (the "Contracts").

Such name change was properly effected pursuant to Delaware law by the filing of the Certificate of Amendment and Restatement to the Certificate of Formation with the Secretary of State for the State of Delaware on October 29, 2018 with an effective date of November 1, 2018. Such name change was authorized and approved as required under Delaware law by the board of managers and the sole member on October 17, 2018.

In connection with the opinion set forth below, I have examined the Certificate of Amendment and Restatement to the Certificate of Formation and the sole member and board consents, and have examined and relied upon originals or copies, certified or otherwise identified to my satisfaction, of such corporate documents, records and instruments of Enterprise Services LLC, such certificates of public officials and officers of Enterprise Services LLC, and such other documents, and have made such investigations of fact and applicable U.S. state law, in each case, as I have deemed necessary or appropriate to render the opinion set forth in this letter. I have assumed that all signatures on such document are genuine and each document issued or certified by a public authority is accurate, complete, and authentic.





Based on the foregoing, I am of the opinion that effective as of November 1, 2018, the legal name of Enterprise Services LLC was properly changed to Perspecta Enterprise Solutions LLC under Delaware law.

I am not admitted to the Bar of the State of Delaware and am not expert in the laws of such jurisdiction.
