

## Background

Intelligent Decisions, Inc. was awarded contract FA8732-15-D-0026 on 2 April 2015. Subsequent to that date Intelligent Decisions, Inc. converted to Intelligent Decisions, LLC and later changed its name to ID Technologies, LLC.

Applied Insight letter dated April 28, 2018, Subject: Novation of certain prime contracts from Intelligent Decisions, LLC to its wholly-owned subsidiary, Applied Insight, LLC, as part of an internal company restructuring/consolidation, requested DCMA Hampton, EHAA recognize the assignment and transfer of the Transferor's Services Division to the transferee.

AFLCMC/HICK PCO letter dated 2 October 2018 assigned contract administration for processing and executing Novation and Change-of-Name Agreements for contract FA8732-15-D-0026 to the DCMA Hampton EHAA Administrative Contracting Officer. (Contract Attachment 10)

DCMA Hampton, EHAA issued contract FA8732-15-D-0026 modification ARZ998 dated 2018 Dec 21 executed the Novation Agreement, whereby the Government recognized APPLIED INSIGHT LLC as the successor in interest of INTELLIGENT DECISIONS, LLC for the contracts listed in modification ARZ998.
