The purpose of this modification is to clarify language regarding the Period of Performance of the Master IDIQ Contract. This modification clarifies that the Master IDIQ Contract remains active until performance of the final order is completed. Therefore, this modification extends the Period of Performance from seven years to ten years. Furthermore, the fourth option period is in effect from 2 April 2021 through 1 April 2025.

- A. The following actions will continue to occur after the expiration of the ordering period which is 1 April 2022.
