The purpose of this modification is to clarify language regarding the Period of Performance of the Master IDIQ Contract. This modification clarifies that the Master IDIQ Contract remains active until performance of the final order is completed. Therefore, this modification extends the Period of Performance from seven years to ten years. Furthermore, the fourth option period is in effect from 15 May 2021 through 14 May 2025.

- A. The following actions will continue to occur after the expiration of the ordering period which is 14 May 2022.
- (1) The contractor's performance at the contract level will be assessed by the Government and reported in the Contractor Performance Assessment Reporting (CPARs).
  - (2) The contractor shall deliver reports as set forth in the Performance Work Statement (PWS) paragraph 5.
  - (3) Contract changes by the PCO after expiration of the ordering period (reference contract clause G-019)

  - (a) ID/IQ Contract Ordering Period: The ordering period shall be from 15 May 2015 through 14 May 2022. for a three-year basic period and four one-year option periods, if exercised.
  - (b) Task Order Period of Performance: Task Orders may be issued during any of the contract ordering periods. The performance period for each task order shall be cited in each individual order and may extend beyond the expiration date of the IDIQ contract ordering period which is 14 May 2022. this ID/IQ contract.
