The purpose of this modification is to Exercise Option Period Four, change Clause H140, incorporate clauses in Section I, and rescind FAR Clause 52.222-59, Compliance with Labor Laws (Executive Order 13673) (Dec 2016).

A. In pursuant to FAR Clause 52.217-09, Option to Extend the Term of the Contract, the Government hereby exercises its option to extend the contract as follows:

- 1) Period of performance is 21 June 2018 through 30 March 2019.
- 2) The following CLINS: 4100, 4200, 4300, 4400, 4500, 4600 and 4700 are exercised.

B. Change paragraph 4 to Clause H140 Special Provisions for Small Business Companion Contract Awardees (Nov 2009) as follows:

FROM:

4. Once a small business companion contract holder transitions, that contractor will only compete for task orders in the unrestricted pool of awardees. The ordering period for small business companion contractors being added to the unrestricted pool will coincide with the unrestricted pool's period of performance, inclusive of options, but shall not extend the overall term of the contract beyond the original performance period nor shall it reestablish the contract base period, inclusive of options.

4. Once a small business companion contract holder transitions, that contractor will only compete for task orders in the unrestricted pool of awardees. **The period of performance and ordering period for small business companion contractors being added to the unrestricted pool will coincide with the unrestricted pool's period of performance and ordering period inclusive of options**, but shall not extend the overall term of the contract beyond the original performance period nor shall it reestablish the contract base period, inclusive of options.

Option to Extend Services (Nov 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 60 days of the end of the option period.

(a) *Definitions.* As used in this clause--

Long-term contract means a contract of more than five years in duration, including options. However, the term does not include contracts that exceed five years in duration because the period of performance has been extended for a cumulative period not to exceed six months under the clause at 52.217-8, Option to Extend Services, or other appropriate authority.

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR part 121 and the size standard in paragraph (c) of this clause. (i) Within 60 to 120 days prior to the end of the fifth year of the contract; and

(ii) Within 60 to 120 days prior to the date specified in the contract for exercising any option thereafter.

(c) The Contractor shall rerepresent its size status in accordance with the size standard in effect at the time of this rerepresentation that corresponds to the North American Industry Classification System (NAICS) code assigned to this contract. (d) The small business size standard for a Contractor providing a product which it does not manufacture itself, for a contract other than a construction or service contract, is 500 employees.
