SUBJECT: Oracle Enterprise Software License Agreement (ESLA, contract W91QUZ-06-A-003)
Announcement

1. On 28 February 2017, the Air Force awarded a five-year Oracle ESLA (base year plus four option periods) with Periods of Performance from 01 March 2017 to 28 February 2022 to Mythics, Inc. The ESLA provides an Unlimited License Agreement (ULA) for 15 Oracle technology products, consolidates over 600 Oracle contracts throughout the Air Force, and delivers Oracle Advanced Customer Support engineers. Also, the ESLA offers maintenance and technical support services for all Oracle software purchases covered under the ESLA. All AF organizations, to include Combatant Commands in which the AF serves as the executive agent, in the Continental United States and outside the CONUS are enrolled in the agreement with the exception of the Intelligence community, Special Access Programs, and USTRANSCOM.
2. Effective immediately, the Air Force is enforcing a moratorium of all new and renewal contract actions for Oracle products and maintenance support provided under the ESLA. The ESLA supersedes all active individual Oracle contracts. My staff has been working with Oracle to adjust and pro-rate costs for active contracts where applicable. The moratorium does not apply to organizations or products not covered under the ULA. Oracle products not included in the ULA are available through a special price hold program identified in the contract. These products are required to obtain an approved J&A through local contract actions and price hold items may offer the lowest price.
3. Along with expanded licensing and support, the ESLA provides approximately \$159M in cost avoidance over a five-year period. To advance cloud strategy imperatives, during the base year, AF users have access to various Oracle cloud services to deploy test and development products in Oracle's cloud environment at no additional cost. Additionally, the Mythics License Orchestrator (MLO) portal is available to all AF users to request, acquire and manage Oracle products. The portal provides an enterprise view of license inventory, usage metrics, and real-time return on investment calculations.
4. The Oracle ESLA is currently being centrally funded by SAF/FM and A5/8 through Feb 2019. A follow-on effort will identify programmed dollars to support or aide contract funding over the Future Years Defense Program (FYDP). It is imperative that all software usage be monitored closely to restrict unneeded cost growth. OVERVIEW

The Air Force Oracle ESLA provides an unlimited license agreement for a core set of Oracle technology products and consolidates the vast majority of the Air Force's core technology maintenance stream. Oracle Advanced Customer Services are available as well as a catalog with established discounts for Oracle core technology products during the term of the contract. The ESLA will allow for improvements in Oracle license management, will accommodate use of Air Force Oracle software in a joint environment, and will replace multiple Oracle products approaching end-of-life.

Eligible entities on the ESLA include the US Air Force, including SAF Pentagon, except for the following entities which are excluded from the definition as used herein ("excluded entities"):

- SCI and/or Special Access Programs/Special Access Requirements (SAP/SAR)
- USTRANSCOM
- USCYBERCOM
- USSTRATCOM - J2 functional areas, Joint Functional Component Commands (JFCCs), Joint Task Force Support Command (JTFSC)
- Combatant Commands (J2 functional areas)
- Air Force A2 Intelligence Systems, and Air Force Intelligence Surveillance and/or Reconnaissance (AF-ISR) components including but not limited to AF-DCGS
- Military Intelligence Program (MIP) and National Intelligence Program (NIP) funded Air Force Programs outside of A2.
- "Internal and external business requirements" as authorized by the agreement shall exclude the Air Force intelligence mission.
